Wednesday, November 7th, 2012

United in Diversity: Migration, Immigration & Integration

To begin the conference, the honourable Yasar Yakis, the former foreign minister of Turkey gave a lecture on the role of Turkey in acting as a bridge between Europe and the Arab world. Mr Yakis discussed a number of current issues in the Arab world including secularism and the Arab spring. Following on from this, Ferry Pausch raised the issue of sports in cultural diplomacy, its role and how effective projects, such as their Deutschlandstiffungs integration program can be in building dialogue between groups. Yasir Yakis and Ferry Pausch were then joined by Dietrich van Kyaw, Dr. Goetz Kaufmann, Wolfgang Jockusch, Sarmad Hussein and Amela Malja to take part in an interactive panel discussion on the topic of 'Integration of Immigrants in Germany & the EU: Best Practices'. Throughout this lively debate a number of important topics were raised including; the nature of integration in countries such as Germany and America, how Germany's attitude towards integration has changed in the last 20 years and what more can be done to facilitate access in Germany. After a short lunch break, participants were invited to the Danish embassy, where they were greeted by Brigitte Tovborg Jensen

the Danish cultural Attaché, who gave a fascinating insight into the biking culture in Copenhagen and what that brings to Danish identity. ICD masters student Virginia Palm then gave a lecture on the topic of Cultural Bridges through film, discussing the idea of cinema for peace in the framework of the Berlinale film festival. Following on, participant Marijanca Ajsa Vizintin presented her paper on The Integration of Immigrant Children of the first Generation and Intercultural Dialogue in Primary Schools, using her native Slovenia as a case study. This was an insightful lecture, given the wide representation of ethnic minorities in Slovenia, which can serve as a notable example to other diverse nations. Participants were then taken to the German parliament where they were given a guided tour. The final lecture of the day was given at the ICD house of Art and Culture by Hans Josef Fell, on the subject of the Energiewende in Germany. Mr Fell raised a number of key topics and gave valuable insight into what it a crucial topic facing modern Germany. To conclude the day, participants were taken to the popular Greek restraunt, Ak Niko Ach on Kufuerstendamm, where good times were had by all.

Thursday, November 8th, 2012

Islam in Western Society and Bilateral Relations between Countries

Events on Thursday began at the ICD house with a lecture from ICD founder and Director Mark C. Donfried on building cultural bridges between Germany and the USA, with reference to the 2012 American presidential elections. His lecture explored a number of aspects of the relationships, from historical point of view as well as a look to the future. Harald Leibrecht and Erin Lotter, members of the German parliament, then joined participants at the ICD house to present their lectures, on the role of civil society in transatlantic relationships and strengthening intercultural understanding at a parliamentary level respectively. Following this was an interactive panel discussion involving Mr Lotter, Mark Donfried and Yasir Yakash on the Visions of Islam in Germany & Western Society. This proved to a lively topic of discussion, with a number of issues being raised by both panelists and participants. In order to gain a German perspective on multiculturalism in the country, participants visited

the German federal agency for civic education, where Marco Michel discusses both the importance and challenges of building a multicultural society in Germany. Returning to the ICD house, Wafaa Al-Natheema then presented a paper entitled, Participant Paper: "The History of Arabs - Bridging Cultures with Knowledge of the Past". Subsequently the Ambassador of Pakistan to Germany, His Excellency Ambassador Abdul Basit shared his insight on the relationship between Pakistan and Germany, giving particular focus on the Context of Globalization and Multiculturalism. Concluding the day's events, Yasir Yakish moderated a discussion between participants on the question of "Can Islam subsist in Western Society?" this contention subject provided an number of enthusiastic responses. Afterwards participates were invited to dine at 'Swera' a popular Pakistani restaurant, where good times were had by all.

Globalization of Multiculturalism

In celebration of fall of the Berlin wall, participants were taken to the 'Berlin Wall Memorial Ceremony'. Later that afternoon, at the ICD House of Art and Culture, the Ambassador of Moldavia to Germany ,H.E. Amb. Aureliu Ciocoi presented a lecture on the subject 'The Eastern Orientation/Policies of European Union and the European Orientation of Eastern Europe'. The lecture proved fascinating as a number of relevant points were raised on the idea of promoting multiculturalism. Shortly afterwards CDU party member, Kaspar-Laurenz Reif was given the opportunity to present a lecture and discussion, chosing the topic of 'Immigration and Identification - from Multiculturalism to proactive Integration'. This lecture discussed in detail the history of German multiculturalism from

the 'Gastarbeiter's' arrival in German society, right up until the present day. From a quite different perspective, what followed was a presentation from Slovenian embassy secretary Marko Tucin on the multicultural challenges facing a small country. Next Narcisa Šabić gave a very slick presentation of her paper on the theme of 'Cosmopolitan Solutions for Multicultural Reality of Europe', which was well received. Finally the conference was ended by German parliament member Ingrid Hoenlinger, who gave a though provoking lecture entitled, 'A Vision of Democracy', exploring what the future of democracy may hold. The conference was then rounded off by a farewell presentation by Mark Donfried and Yasir Yakish, and a farewell group dinner.

Speaker Interviews



Hans-Josef Fells, Member of the German Parliament

During the interview Mr Fells faced question facing on a number on topics;

On the subject of his interests and his job Mr Fells described the relations between pollution destroying the world we live in and how this makes it difficult for us to live together. By creating a environmentally conscious world people can live together.

When asked about being about a signatory to the Prague declaration by the European commission, he spoke about his pride in signing this, he felt that the nature of Nazism and Communism in Europe where perfect examples of how totalitarianism is detrimental to multiculturalism.

An interesting question on the supposed failure of multiculturalism was posed, to which Mr Fells responded by suggesting that indeed many politicians see the idea of multiculturalism as a threat to national identity, but believed the majority of Germans did not feel this.

In response to the question that Islam was incompatible in a country like Germany, he reminded the audience that Islam is by nature a peaceful religion, of course there are prejudices as a result of extremism, but there should be no suppression of Islam.

As a member of the green party he was probed on what the part could do to meet the energy needs of the future, Mr Feels raised several interesting points; that currently energy production was very centralised, jobs and opportunities could be created with renewable energy and act as a means of cultural diplomacy as localised decision making on energy could help promote dialogue.

Speaker Interviews



Erwin Lotter, Member of the German Parliament

On the idea of multiculturalism being negative to the development of society and threat to identity, Mr Lotter challenged this instead pointing out that each member of society can learn from each other, giving the example of cuisines, and how diversity in this sense is encouraged.

It was put to Mr Lotter that Islam could be an obstacle to integration; he acknowledged that this could be true, but only in the case of extreme fundamentalism, explaining that this is a result of peoples interpretation of the religion, not the religion itself.

When asked to comment on whether multiculturalism was developing or dead, Mr Lotter was convinced that it is still developing, whilst it is the responsibility of each 'Laende' to promote this, he acknowledged that whilst work is being done to improve the current policies, more still needs to be done.

His party is deeply liberal, guaranteeing individual freedom to all, in terms of multicultural policy he believed it essential that all cultures accept each other. Rather than take an approach of 'sterilizing' the country from expressions of different cultures, it should be promoted and understood and that unity can and must come from a universal acceptance of the country's constitution.

Looking to the future, Mr Lotter is strongly in favor of a unified Europe, one based on fundamentals such as liberalism and democracy.



Speaker Interviews



Ingrid Hoenlinger, Member of the German Parliament

Speaking about how the government can develop integration policies, Ms Hoenlinger believes a greater use of dual nationality would allow people greater representation and feelings of inclusion.

A question was posed on the idea of islamification being a threat to Germany, to this she replied that it is certainly a challenge however there is much that both cultures can learn from each other.

In response to the notion that multiculturalism has failed in German, Ms Hoenlinger proposed that it is inevitable that in a globalized world cultures must deal with other and there are mutual gains for everyone if multiculturalism succeeds.

She gave a good example of multicultural interaction on a local level, discussing an international breakfast she attended in her local town, where people from many different backgrounds were able to interact.

"I would not call Turkey an Islamic country; it is a secular country with a predominant Muslim population. Therefore it is more proper to use the term 'member country of Islamic countries'"

"The salad bowl model concerns talking about individuals, but to make the salad tasty we need the sauce to connect these individuals. Music, sports or other shared interests could be this sauce, enabling the mutual understanding by taking part in a common activity, independent on a single culture"

"Instead of the term 'Multiculturalism' I prefer the word 'Interculturalism', which expresses the ideas we are talking about better. There is no need to show understanding in everything, but it is important to show respect towards other cultures"

Wolfgang Jockusch

"Small countries tend to protect their national identity more than the big ones. Especially in the case of young countries, which need to re-develop their national identity whereas on the other hand, they are dealing with building a multicultural society"
